- 3. if applicable, the School may request from our child's present nursery or educational establishment: (a) information and a reference in respect of our child; and/or (b) information about any outstanding fees and/or supplemental charges;
- 4. the School may process any personal data about us (or either of us) and our child, including sensitive personal data about our child (such as medical details), for the purposes of:
  - (i) administering its list of prospective pupils;
  - (ii) its registration, selection and/or admission procedures, including as set out above; and
  - (iii) communicating with the parents of prospective pupils about the School and generally managing relationships between the School and its prospective pupils.

## 5. Notice Requirements

- (a) <u>Notice to withdraw your child from Little Oaks Nursery</u>. If you wish to withdraw your child from the Nursery (other than at the normal leaving date), you must either give us a clear term's notice to that effect or pay to the School a term's fees in lieu of notice, at such rate as would have been charged for the final term of provision if a term's notice had been given. This means that if, for example, you wish to withdraw your child with effect from the start of the Michaelmas term (i.e. at the start of an academic year) then you would need to tell us in writing that you wish to withdraw your child on or before the first day of the preceding summer term (i.e., the final term of the preceding academic year).
- (b) <u>When the relevant amount in lieu of notice must be paid</u>. In cases under (a) above, the appropriate sum in lieu of notice will become payable by you to us as a debt on the
